## Artists' Schedule

Please keep and read these pages for rules and information

- This is an independently juried competition open to any local artist.
- Cost is \$35.00 for Non-GHA Artists and \$25.00 for GHA Members /Students
- Registration deadline: Jan.10<sup>th</sup>, 2020
- **NO registrations will be taken on the day of the event.**

### Jan. 18th:

1. Enter at the Main Gate of the Deering Estate-identify yourself as a paid participant for Affair En Plein Air. **Students are allowed to be accompanied by 1 adult chaperon, additional persons must pay for their entrance to the estate.**
2. Registration begins at 10 am in front of the Pump House. You will receive an envelope with your name tag, and labels to save. Painting begins at 10am until 4pm.
3. You may choose any exterior location on the estate to work.
4. Coffee, light snacks and water will be available for participants only.
5. 4pm - all art work is to be brought to the Pump House Meeting Room to be checked in for the night. You can also leave any easels, etc. there overnight, since it will be closed & locked.

### Jan. 19th:

1. Registration will begin 10 am in front of the Pump House. ID badge must be worn.
2. Painting begins at 10 am until 1 pm .
3. Coffee, light snacks and water will be available, for participants only.
4. Between 1- 1:30 pm – all work is to be brought to the Carriage House for judging. Work should not be signed on the front/ your registration label with your assigned number should be placed on the front of the work,
5. **Please bring Easels or something to display your work on to judging area.**
6. No one is to remain in this area during the time that the judge is making his/her decision.
7. Judging will begin at 1:30 pm at the Carriage House.
8. Adults and students will judged onsite and winners announced and prizes will be awarded at the GHA Exhibit on TBA

## **Rules and Information**

En plein air (French pronunciation: [ɑ̃ plɛn ɛːʁ]), or **plein air** painting, is a phrase borrowed from the French equivalent meaning "open (in full) air". **All work is done on site and the use of photos or recorded images is not allowed.**

1. **All work must depict something on The Deering Estate. Both traditional & contemporary interpretations are encouraged. Participants shall, under no circumstances, include any inappropriate or offensive nudity, political, religious, or racial comments as part of any art work. The Estate, through its Director, shall have the right to remove any & all art work that they deem inappropriate or offensive. Any artwork(s) to be displayed at the Estate must be approved & accepted by the Deering Estate**
2. **Participants may work in any medium, but work must be completed on the Deering Estate premises during the time frames specified for the Affair En Plein Air.**
3. **Artists may work on any of the porches as long as they cover the work area with plastic or a protective covering.**
4. **If you wish to come and see the Estate before the event you will be charged regular entrance fees.**
5. **We request that participants credit all work that is exhibited or reproduced elsewhere, as such: "Produced while visiting the Deering Estate"**
6. **Additionally, all work that is created or reproduced while on the Estate or using Estate images shall not be for commercial use, & can only be made available for private exhibit or private sale.**
7. **Artwork size limitation may range from 8x10 to 20x24.**
8. **Artists are expected to interact with anyone asking questions about your creation therefore, headphones are not permitted**
9. **Trash is not to be left in the area where you work.**
10. **Smoking, alcohol consumption & illegal drugs are not allowed anywhere on the Estate.**
11. **Prizes will be awarded by an independent juror. No one except the juror & committee members will be allowed to be present at the judging.**
12. **Any unclaimed work will be considered abandoned & will become the property of GroveHouse Artists**
13. **Participants agree to comply with the Deering Estate Park Rules & Regulations.**

### **For En Plein Air Artists**

- **Canvases or work surface can be primed in advance and must be completely blank at the start of the competition.**
- **Artists must report to the registration table at the beginning & end of each day.**
- **All artists must wear the ID tag given to them at registration while on the property,**
- **Artists must provide all of their own supplies, including an easel .**
- **Each piece of art must be labeled with the GHA tags provided.**
- **There will be coffee, light snacks and water available, please bring a lunch.**
- **All art is to be left in the designated room at the end of the day; no artwork is to leave the property before the end of the event.**
- **Small Tents and umbrellas may be used but not staked to the ground. Dirty water or chemicals are NOT to be poured out onto the grounds.**
